

💲 Your Will

Many people do not like to think about death and maybe you have not given thought to preparing for the eventual. Sadly, we all know that an accident or an illness can occur at any time to anyone. Death is one of the few certainties and when it occurs, a Will can help make things easier for those you care about.

When it comes to making a Will, you owe it to yourself and those you care about to make sure that it is precisely worded and accurately reflects your wishes, and that the administration will be professionally carried out. You can amend your Will at any time.

S Benefits of making α Will

There are benefits which include the following:

 There is no need for sureties or guarantors when application is made to the court for obtaining probate.

- Court procedures are simpler and faster than in the instance where a person dies without having made a Will.
- There is less friction and misunderstanding between beneficiaries and relatives.
- There is clear understanding when gifts are made to organisations and charities.

If you do not decide on the distribution of your assets through your Will, your estate will pass in accordance with government regulations.

Preparing your Will

Always seek professional legal assistance when preparing your Will. Your lawyer, public trustee or trustee company will help you ensure your Will is valid and accomplishes what you want. Any change in your circumstances could make it necessary to update your Will. To ensure your Will remains current, have it checked by your lawyer, public trustee or trustee company every few years.

For your Will to be valid, it must be witnessed in the same pen by two adult people of sound mind who are NOT beneficiaries or spouses of beneficiaries. Ensure that witnesses also print their name and address when signing

as witness to a Will. If there are beneficiaries who are minors (persons under the age 21 years) named in your Will, it will be preferable to have at least two executors/ trustees who would be able to hold any assets or invest or use any money for the benefit of the minors.

Your Legacy can help others

There will always be people in need of assistance beyond your lifetime. You can extend your giving by bequeathing a contribution to The Salvation Army (Unique Entity Number: T07CC3012G) through your estate.

You can give through your Will, insurance policies (a sum or entire policy), annuities or Central Provident Fund (CPF). It is important to remember that the CPF Board will recognise the intention as expressed by a member only when it is filed with the Board via the CPF Nomination Form and you may wish to include The Salvation Army as one of your nominees when doing so.

Your contribution, big or small, will help sustain lives and build a more caring community. Thank you for including The Salvation Army in your legacy and for making a lasting difference in the lives of the disadvantaged.
